CORPS MEMBERS ALSO RECEIVE CONTINUOUS MENTORING LED BY A SOCIAL JUSTICE ADVOCATE, SOFT SKILLS TRAINING, GED TRAINING AND TESTING THROUGH PARTNER AGENCIES, AND JOB PLACEMENT SERVICES.
