THE CURRENT PROGRAM STILL PERFORMS THAT SERVICE AS WELL AS OTHER TYPES OF CONSERVATION PROJECTS. OUR CURRENT CONSERVATION WORK INCLUDES REBUILDING AND RESTORING WETLANDS AND ECOSYSTEMS; CREATING WILDLIFE HABITAT; BUILDING URBAN GREENSPACES AND FOOD GARDENS; CONSTRUCTING RAIN GARDENS AND OTHER STORMWATER MANAGEMENT PROJECTS; PLANTING TREES AND NATIVE SPECIES PLANTS; FOREST CONSERVATION; BUILDING AND REPAIRING TRAILS, BRIDGES AND BOARDWALKS; WEATHERIZING AND RETROFITTING HOMES WITH ENERGY AND WATER CONSERVATION UPGRADES; AND PERFORMING EDUCATIONAL WORKSHOPS ON ENVIRONMENTAL STEWARDSHIP AND CONSERVATION.
